

Steps to Starting a Business in Wilkesboro

Step 1

ZONING COMPLIANCE

A Zoning Certificate of Compliance is required. All proposed uses must comply with the Town of Wilkesboro zoning, watershed, and flood damage standards and ordinances to protect the public health, safety and welfare of the citizens of the town and extraterritorial jurisdiction (ETJ).

Step 2

SIGN PERMIT

A building permit is required for a ground sign. All sign permit applications must be completely filled out, contain supporting paperwork and be signed prior to Town review.

Please verify the following information has been included on an attached drawing:

- Location of sign on property
- All sign dimensions: length, width & height
- All graphics, colors & fonts
- Length of street frontage
- Sign is located out of public right-of-way
- Freestanding signs have no more than two sides
- Height above the ground
- Verify that there is remaining allowable sign area at the proposed location

Step 3

FIRE INSPECTIONS

Wilkesboro Fire Inspector's Office is a division of Town of Wilkesboro Fire Department. This office is designed to provide Wilkesboro's business, industries, churches and the public with basic information about fire code prevention.

The staff conducts fire inspections on all commercial and some residential occupancies. The staff issues required fire permits and conducts plans review for new construction. All Inspectors are certified through the NC DOI and NC Code Officials Qualification Board.

Step 4

UTILITY BILLING

New accounts CANNOT be setup over the telephone. You will need to bring the following with you into Town Hall.

1. All new customers must provide the following:
 - Telephone number
 - US Government photo ID
 - Social Security Card or Federal Tax ID (*business*).

2. Payment is required before utilities can be connected.

- Activation Fee \$15.00
 - Residential \$75 *
 - Commercial \$125 *
- If above Identification cards / FID number is not provided, the *refundable deposit will increase to following rates:
- Residential \$150*
 - Commercial \$300*

BEER/WINE LICENSE

Any business inside the town limits of Wilkesboro selling beer or wine for on-premises or off-premises consumption should be paying the applicable local beer and wine tax. G.S.105-113.77 (city) .
